Consultation with the public until 7.10pm - 1 present, no issues. Mr Andrew Pakes, MP in attendance

- Concern expressed at the Planning application for 265 houses near Eye Primary School being passed for outline planning despite objections from the MP at the time, Ward Councillors, Parish Councillors and many members of the public.
- Details are now being dealt with for the development.
- Main concerns is for the infrastructure of the village which has not kept pace with recent years developments ie roads, schools, etc despite the Planning Inspectorate recommending that the infrastructure should be improved before any further development takes place.
- Eye library is still open, Eye Youth Club is run by volunteers from the village. Concern that Eye village is slowly joining Peterborough and losing its Green Wedges.
- Eye Primary School is at capacity now plans were drawn up for the schools expansion in 2018 which are now out of date. One planning meeting with the City Council and the school held recently but much more work need on the plans.
- The Local plan for Peterborough is being reviewed and if all the proposed development for Eye is permitted there will be 2,8750new housed being built in Eye.
- Police presence has been minimal at the Parish Council keep Mr Parkes informed on this. Police Surgery for the public to be held in the Leeds Hall next week.
- Mr Parkes was thanked for his attendance and promised to return to the Parish Council meetings periodically

427 pupils on roll

The proposed expansion plans are for a 2 storey building with 4 new classrooms. Allocated budget not believed to be adequate, at least September 2026.

4) Items for City Councillors

- Email received from the organisers of the Thorney and Eye Food Bank asking for assistance as they have been given notice to vacate their premises by the City Council.
- Coun Ormston explained that the premises must be closed due to Environment Health concerns and the City Council are working to find premises for the foodbank in the short term and a long term permanent solution.
- Thorney Library is not closing as has been reported.
- The Manor Farm Community Centre roof is still leaking.
- Disappointment expressed that emails to City Council Officers often go ignored.
- Half of the Skate Park Lights are now working Coun Ormston still chasing
- Police aware of residents door being tried to gain entry.

- The manhole cover at Millort Drive is not a City Council one.
- The asbestos seen dumped at Storey Barr Road is being dealt with, although not in Eye Parish thanks to member for reporting it.
- Earth on the grass verge/footpath at Daltons Seed been investigate, used as a bund.
- There is an issue with flooding in Crowland Road at Sue Ryder due to the fall of the road, Highways aware but no funds to repair.
- The clothes bank in Lukes Lane is being looked into by PCC as they do not know who owns it.
- Planning application for Enterprise cars in Peterborough Road has been objected to and is with the Planning Department.
- Issue with 37 bus service no longer going into Blue Diamond Garden Centre and not informing customers.
- Number of patients for Eye Surgery requested for Neighbourhood Plan but no response received.
- Developments on High Street has meant contractors parking on the grass verges and mud on road, should reinstate when work completed.
- Still concerns with shop in the High Street selling vapes to children.
